The Military had to be called out and the Magistrate and the Police Inspector on the spot informed immediately by wire the Administrator at Salisbury of the incident who replied that the interests of the Indians must be protected and that the action of the demonstrators was illegal and ordered their prosecution. The result was that the ring-leaders were bound over to keep the peace, and Mr. Bhimjee succeeded in vindicating the rights of the Indians. The history of the Indian trade in Southern Rhodesia

begins from this period.
